Laramie Energy intends to reperfurate and raise the packer on the BCU 12-4 SWD. To provide the best opportunity for the packer elements to seal and maintain zonal isolation, the packer will be raised from the rough casing at 8440' to the center of a smooth casing joint at 8375' as identified by a 40-arm caliper log dated January 21, 2017. A procedure is attached.
