What was Pad area is revegetated and comparable to reference area vegetation; however the Access road has not been reclaimed. 6S Doc#1174583 was filed for this Well with Plugging date of 3/31/2004 & checked that Marker was installed. Dry Hole Marker and what appears to be Well head was noted on site. Well sign \(Debris\) is on ground next to apparent Well head. Refer to Photo Log attached.](#)

Corrective Action:	Perform Final Reclamation per COGCC 1004 Rules, removing debris, abandoned riser (Well head?), reclaiming /reseeding any areas disturbed by removal activities. Reclaim Access road; including, re-contouring and seeding; installing appropriate BMPs to stabilize the site until uniform vegetation establishes across the disturbed area.
