Encana respectfully requests continued TA Status for the subject well.
The well was TA'd due to sub-economic production. A CIBP was set at 5050' and topped with 2 sack of cement, which covers the Rollins perms at 7304'-7316'. There is no tubing in this well and the master valve on the wellhead is closed to insure the well is closed to the atmosphere.
Encana plans to review the economics and future development prior to the next MIT before 4/4/18.
