Comment: This location does not meet COGCC 1000 series reclamation requirements and standards. Surveys conducted indicate that the crop vegetation on the location/disturbance area is not reflective of the reference area, and that issues appear to exist that are hindering the reclamation of the location. In addition, subsidence concerns remain at the well: this issue has been identified in previous inspection. See attached photo and data sheet documents.

Corrective Action:	Perform reclamation on location in accordance to COGCC 1000 series standards and requirements. To allow time for operator to 1) Collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities, or crop production, and 2) to allow operator time to perform any needed tests to determine the issues on location that are hindering reclamation, all reclamation activities will be conducted by 8/15/2018	Date	08/15/2018
