Comment: [Location does not meet Final Reclamation requirements. Vegetation in areas of Site is composed mainly of Cheat grass & Kochia. There are bare compacted areas. Site appears to be utilized as livestock loafing area, several salt licks were noted. Debris is present on perimeter of Location. Two track road remains to Site. 6S Doc#1398984 was filed for this Well with Plugging date of 8/18/2000 & checked that Marker was installed; though only what appears to be Well head was noted on site.](#)

Corrective Action:	Perform Final Reclamation per COGCC 1004 Rules, removing debris, abandoned riser (Well head?), include any re-contouring needed (site is relatively flat), seeding of site and access road. Install and maintain appropriate BMPs to stabilize the location until a uniform vegetation establishes across all disturbance areas. All Reclamation Activities to be complete by November 1, 2018.
