*RE: Agreement to Toll Commission Rule 303.c.2 Right to Request Hearing*

Dear John,

Extraction Oil & Gas Inc. ("Extraction") is currently working with Commerce City (the "City") on the local land use permitting process for several oil and gas locations within the city limits. Discussions and negotiations regarding the local permitting process may take several months to complete. In an act of good faith and in the spirit of our ongoing negotiations with the City, Extraction temporarily tolls its rights to a hearing under Commission Rule 303.c.2 and Commission Rule 503.b.(6) on its pending COGCC Forms 2A and 2 currently filed and pending with the Colorado Oil and Gas Conservation Commission ("Commission") for the oil and gas locations and associated wells planned to be located in Commerce City until September 30, 2018.

A list of the pending permits is attached as Exhibits A & B for which Extraction tolls its rights to seek a hearing under Commission Rule 303.c.2. Additionally, Extraction has submitted Drilling and Spacing Unit Applications for the Owl and the Hawk wells and anticipates submitting Form 2s for those associated wells in the near future. Extraction reserves the right to lift its request to toll the time to pursue a Rule 303.c.2. hearing in the event that Extraction and the City complete its negotiations in advance of four months. In that instance, Extraction will submit notice to the Commission staff, of the continuation of the COGCC permitting approval process on the pending permits.

Additionally, when the toll is lifted for the 303.c.2 hearing, Extraction requests a 10-day comment period under Rule 305.d.
