Corrective Action:	This location is not in compliance with Rule 1004. Well was plugged 8/3/2016. A List B CO Noxious weed, scotch thistle, was observed at the location. There are areas that initial reclamation activities were not successful. Plant species observed include but are not limited to Agropyrum cristatum, Bromus inermis, Pascopyrum smithii, Sporobolus airoides, Thinopyrum intermedium, Tragopogon dubius, Podospermum laciniatum, Bromus tectorum, Lactuca serriola, Convolvulus arvensis, and Cirsium arvense was observed at the location. 	Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Remove remaining fence and weedy debris. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Manage noxious weeds by 6/20/2018 due to that flowers will develop shortly. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards.
