**Photo 1.** Photo taken from the entrance of the location, facing West. Ditch and berm BMP has been installed. The berm BMP has not been stabilized and left unconsolidated. An unconsolidated berm BMP is not a proper functioning BMP, as the unconsolidated material becomes a source of potential pollution itself and susceptible to wind and water erosion. The well location has been graveled throughout the area.
