Colorado Oil and Gas Conservation Commission (COGCC) Rule 318A.a requires wells to be drilled in a square with sides 400 feet in length, the center of which is the center of any quarter/quarter section or in the center of any quarter section with the four sides being 800 feet in length. Extraction proposes to drill the above referenced wells between 40 and 220 feet outside of the SENE legal drilling window. These wells have been located outside of the drilling window due to a negotiated Surface Use Agreement (SUA) with the surface owner. Waiver of the subject rule can be found on Page 4 of the SUA attached to the Application for Permit to Drill.

Extraction respectfully requests the COGCC review the enclosed information and approve the exception location request and Applications for Permit to Drill for the wells on the subject pad.
