#### COMMENTS:

Request to flare is being made as a result of Anadarko shutting down their Third Creek System which was the gas sales outlet for the Miller 6-13. It is estimated that approximately 3 MCFD from the well will be flared using a central tank battery combustor. A trace amount (1 PPM) of hydrogen sulfide is present in the gas. A gas analysis from the lease meter is attached.
