Comment: **This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 1/13/2015 and work should have been completed by 4/13/2015. Gravel remains throughout the location which has not been re-contoured or re-graded and decompacted. Please refer to the attached inspection photos for more detail.**

Corrective Action:	Perform reclamation in accordance to Rule 1004. Remove gravel from location; perform compaction alleviation and re- contour/re-grade. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production. Manage noxious weeds by 6/25/2018 due to that flowers will develop shortly. Coordinated with the surface land owner and send a Form 4 by 7/2/2018 detailing the agreed upon reclamation timeline with the surface landowner and seed that will be used.	Date	06/25/2018
