WEEDS	ACTION REQUIRED	Tank battery location was mowed within 2 days prior to this inspection; however, mowing by itself is not a sufficient control for mature Diffuse knapweed during this time of year. Mature Diffuse knapweed individuals were observed along the perimeter of the mowing area. Knapweed seed heads were observed in the mowed cutting areas. Refer to attached photos in Document #682401241.	Operator instructed on 8/25/16 to pull and bag remaining plants in areas that were not mowed. Operator instructed on 8/30/16 to collect, remove, and dispose weed debris and seed heads properly from areas that were mowed.
