Corrective Action:	<p style="color: blue;">This location is not in compliance with Rule 1004. Well was plugged 6/5/2015 and work should have been completed by 6/5/2016. Gravel remains throughout the location which has not been re-contoured or re-graded and decompacted to meet the adjacent terrain. Plant species observed include but are not limited to <i>Heterotheca villosa</i>, <i>Convolvulus arvensis</i>, <i>Hordeum brachyantherum</i>, <i>Bromus tectorum</i>, <i>Podospermum laciniatum</i>, <i>Taraxacum officinale</i>, <i>Kochia scoparia</i>, <i>Lactuca serriola</i>, <i>Medicago sativa</i>, <i>Oenothera albicans</i>, and <i>Conyza canadensis</i>. Please refer to the attached inspection photos for more detail.</p> <p style="color: red;">Perform reclamation in accordance to COGCC 1004 reclamation rules and requirements. Reclaim location and access road. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Remove gravel and perform compaction alleviation, re- contour/re-grade. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards.
