E½E½ of Section 29  
E½E½ of Section 32  
W½W½ of Section 33

Containing 800 acres, more or less, for the Niobrara and Codell formations

Crestone is not the only owner within the proposed spacing unit and, as such, provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A.e(6). The required thirty (30) day notice period has elapsed absent the receipt by Crestone of an objection to said proposal by the owner(s) within the Proposed Spacing Unit for the subject well.
