Comment: Canada thistle has emerged on Location area. Thistle had been reported in 5/13/16 inspection and controlled by 6/23/16 inspection. Lessee (Farmer) of Location indicated that he had sprayed site earlier in the Spring, that thistle had appeared controlled. Timing is not good now because of growth stage of crop and controls will need to be delayed until Spring 2019 when area is Summer Fallowed. Crop growth (density & height) in areas of Location are not commensurate with growth in surrounding field.
