Noxious weeds are beginning to encroach onto the adjacent lands</p> <p>These are Colorado State Listed noxious weed and needs to be managed and removed in accordance to COGCC Rules 603.f, 1003.f, and in accordance to the Colorado State Noxious Weed Act.</p>		
Corrective Action:	<p>Properly remove and control noxious weeds. Ongoing weed management and monitoring is required, and needs to occur in accordance to COGCC rules and regulations.
