Comment: A Program to to control Noxious weeds at location has been implemented since previous Inspection; though Noxious weeds were still seen established across site at this Inspection. B list Noxious Weeds, Dalmation toadflax, Houndstongue and Thistle were noted. C list Noxious weed, Cheat grass is established across site and may interfere with Location passing the 80% of Reference area requirement; competing with desirable species establishment.

Corrective Action:	Continue control of Noxious Weeds. Vegetation should be monitored; if not progressing, control of Cheat grass, inter-seeding or fencing to exclude Livestock may be needed. Operator; notified of Noxious weed problem indicated weed control would be sheduled ASAP.	Date	06/28/2018
