Twenty-two (22) grab soil samples were collected as part of excavation activities. Six (6) additional soil samples were collected via direct push as part of monitoring well installation activities. All soil samples were analyzed for BTEX, naphthalene, TPH-GRO, and TPH-DRO following EPA Methods 8260c and 8015.
