As required by Weld County, and through the issuance of a 1 year temporary road access permit(expires April 2019) KMG will be required to abandon the access off CR 41 after drilling, completions and interim reclamation. If work is still ongoing in April 2019, Weld County will agree to extend the term of the access permit. A permanent access road will be constructed off of CR 10 post interim reclamation. KMG originally submitted the Form 2A with the access off of CR 10, but at the request of the COGCC the access road was relocated to CR 41 due to proximity of nearby building units. Once the wells are on production and the permanent access road is constructed off of CR 10 there will only be pickup truck travel to and from the location a few times per week.
