Comment: **This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 4/28/2016 and work should have been completed by 4/28/2017. Gravel remains along the access road and has not been re-contoured or re-graded and decompacted. A List B CO Noxious weed, Canada thistle, was observed at the location. Electric is left on location. Please refer to the attached inspection photos for more detail.**

Corrective Action:	Perform reclamation in accordance to Rule 1004. Remove gravel from the access road; perform compaction alleviation and re- contour/re-grade. Remove electric left on site. Manage noxious weeds by 6/25/2018 due to that flowers will develop shortly. Final reclamation activities shall be complete as soon as possible no later than 8/17/2018.
