This well was plugged in 2010. We ripped the location, then spread gypsum twice over a period of 4 years. I submitted a Form 42 in 2014, and have no record of the site being inspected since then. In April, I viewed no gaps in the corn stubble, so I believe the location should be ready for final inspection. Likely corn or milo is growing there now. Latitude: 37.15601 Longitude: -102.3509606.
