Comment:

Access road and well location have desirable germination of vegetation but noxious weeds were observed throughout portions of the disturbance area. At a minimum, Operator shall control Canada thistle, as it is a List B Colorado noxious weed. Appears location was recently mowed but mowing operations would not be considered a long term weed control management practice for Canada thistle. Refer to the attached inspection photos

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct follow-up inspections prior to receiving said notice to ensure compliance with Rule 1004.

Corrective Action:

Perform weed control by 7/9/2018 as flowers will develop shortly.
