INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On February 9, 2015, historical hydrocarbon impacts were discovered during abandonment activities at the HSR-Corvi 64N66W36NWNNE production facility. The facility was shut in, associated infrastructure removed, and excavation activities were initiated. Groundwater was not encountered during excavation activities. The COGCC has issued Spill/Release Point ID 440852 for this release. A partially-buried produced water vessel was removed during excavation activities.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Soil samples were collected as described in the initial Form 27. Due to the presence of multiple active subsurface lines, impacted soil was left in-place in the vicinity of excavation soil samples N01@15', S01@15', W01@15', and B01@18'. Between March 5 and 10, 2015, multiple soil borings were advanced around the excavation area, in order to complete delineation of soil impacts. These borings were advanced to the limit of soil impacts observed during drilling; soil samples collected from borings W-BH02, and NW-BH06 exhibited constituent concentrations out of compliance with State standards. Based on the results of assessment activities, remaining impacted soil extends from approximately 10 feet below ground surface (bgs) to the current groundwater table. Soil sample locations and the estimated areal extent of remaining soil impacts are illustrated on Figure 1.

Proposed Groundwater Sampling

☒ Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

The soil borings advanced between March 5 and 10, 2015 yielded groundwater, and as such borings S-BH01, W-BH02, N-BH03, N-BH04, W-BH05, and NW-BH06 were converted to temporary monitoring wells BH01-BH06. Samples collected from these locations indicated groundwater impacts out of compliance with State standards were present at the site. Between August 17 and 25, 2015, 5 additional monitoring wells (BH07-BH11) were installed to further assess the extent of groundwater impacts. Quarterly groundwater monitoring was initiated on March 11, 2015, and is ongoing at the 11 temporary monitoring wells on site. Groundwater samples are collected on a quarterly basis and analyzed for benzene, toluene, ethylbenzene, and total xylenes (BTEX). Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 2. Laboratory analytical reports are included as Attachment A.

☒ Additional alternative investigative actions described in attached Site Investigation Plan (summary):

A partially-buried produced water vessel was removed during excavation activities. The depth to groundwater at the site has risen significantly since excavation activities were completed to a depth of approximately 18 feet bgs in February 2015. Based on the depth to water measurements collected at the site temporary monitoring wells during groundwater monitoring activities, the average groundwater depth at the site is approximately 14 feet bgs. Groundwater samples are intermittently collected from the site remediation wells, as needed, for remediation system monitoring and optimization purposes.

Groundwater impacts out of compliance with State standards were historically detected in off-Site monitoring well BH01. Remaining soil impacts may potentially extend into the adjacent property to the south of the site, as illustrated on Figure 1.

Hydrocarbon impacted soil and groundwater remain at the site. The eleven (11) temporary groundwater monitoring wells will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards for four consecutive quarters. Additional temporary monitoring wells may be installed, as necessary, to maintain point of compliance (POC). Post-remediation soil samples will be collected to verify that site soils are in full compliance with State standards.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

On February 9, 2015, approximately 150 cubic yards of impacted material were excavated and transported to the Buffalo Ridge Landfill in Keenesburg, Colorado for disposal. Remaining impacted soil left in place (as previously described) will be addressed as described below.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

As described, impacted soil and groundwater remain at the site. Based on the results of pilot testing at remediation wells AS-01 and SVE-04, air sparging (AS) and soil vapor extraction (SVE) were selected as the remediation strategy to address remaining hydrocarbon impacts to soil and groundwater at the site. Construction activities for an on-site AS/SVE system were initiated during the First Quarter 2018 and completed during the Second Quarter 2018. System start-up and optimization activities were initiated on May 11, 2018, and are currently ongoing. Remediation well completion logs and the as-built locations of the remediation system wells and conveyance lines will be provided in the next Form 27-Supplemental Annual Update. The approved USEPA Underground Injection Control permit for AS activities is included as Attachment B. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in full compliance with State standards for four consecutive quarters. Estimated time to attain NFA is TBD based on the review of groundwater concentrations, the extent of impacted groundwater, and the efficacy of the selected remedial technologies.

Between March 5, 2015 and November 29, 2017, 11 temporary groundwater monitoring wells and 2 remediation wells were installed at the site to assess the extent of groundwater impacts and/or for remediation purposes. The 11 temporary monitoring wells will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards of four consecutive quarters. Additional temporary monitoring wells may be installed, as necessary, to maintain POC. Groundwater sample locations are illustrated on Figure 2, and a potentiometric surface contour map for the First Quarter 2018 is presented as Figure 3. Well completion logs for the temporary monitoring wells and remediation wells are included as Attachment C.
