CA#1) Perform Final Reclamation per COGCC 1004 Rules including re-contouring, seeding of site and reclamation of access road. Install appropriate BMPs to stabilize location until vegetation establishes; all Reclamation Activities to be complete by November 1, 2018.  
CA#2) Control Noxious Weeds ASAP, at least by 7/23/18. Monitor & control Weeds, until Location is passed for Final Reclamation.
