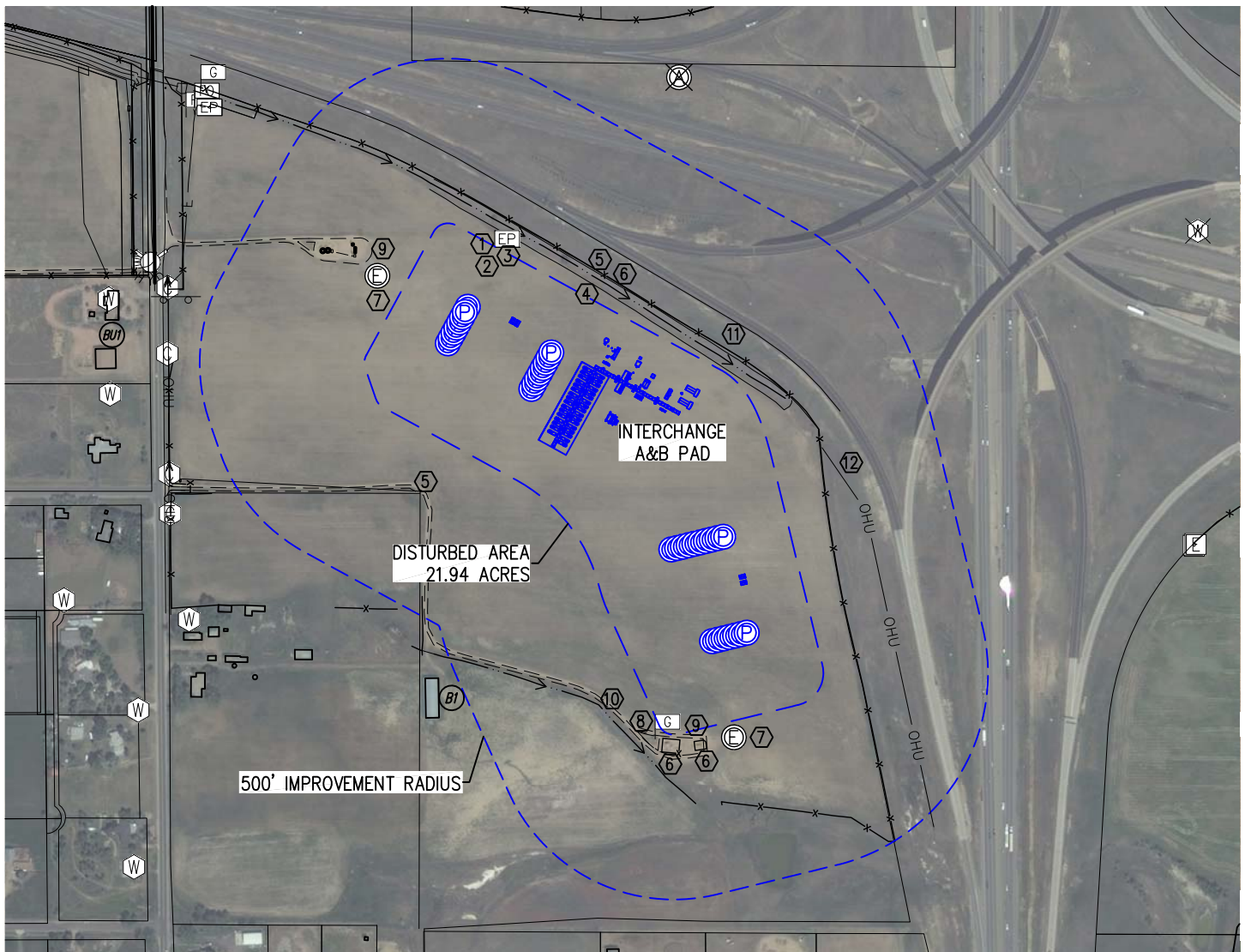


# LOCATION DRAWING INTERCHANGE A&B PAD

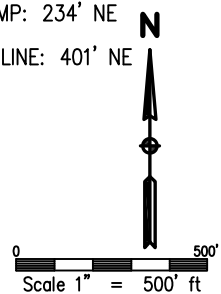
