Comments Distance from completed portion of proposed wellbore to nearest completed portion of offset wellbore permitted or completed in the same formation is to the Critter Creek 16-6401B which is 455' away, this distance was measured in 2D.

Distance from proposed well to nearest well belonging to another operator is 1168 feet, the well belongs to GROSS* TODD and is the Nauta 1 (05-123-07135), this distance was measured in 3D.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 300' FNL and 1241' FWL of Section 9. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
