Evidence of herbicide evident, however spraying does not appear to have been sufficient as many plants appear to be viable and have continued to mature/flower. Additionally, corrective action required removal of the noxious weeds; Diffuse knapweed remains on location. Original corrective action and date remains applicable.</p> | | |
| Corrective Action: | Properly remove and control noxious weeds. Ongoing weed management and monitoring is required, and needs to occur in accordance to COGCC rules and regulations.
