## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Well Foster E Unit 1 was frac hit on March 6, 2018. Bradenhead pressure increased from 15 to 234 psi. The pressure was bled down to 11 psi. A Form 6 NOI was submitted on March 22, 2018. Bradenhead pressure was tested on April 4, 2018, 8 psi. On May 14, 2018 bubbling in some rain water was noted near the wellhead. On May 15, 2018 a plug was set in the production casing above the highest perforated zone. On May 21 and 22, 2018 two more plugs were set in the production casing at 2500 ft bgs and 1700 ft bgs.

After setting a plug in the production casing on May 22, 2018 and a series of plugs from the bottom of the surface casing up, a hole in the surface casing was located between 8 and 41 ft bgs. It appears that the hole in the surface casing was the route any gas and/or liquids travelled to ground surface. The top of the upper most aquifer lies at 100 ft bgs., well below the hole in the surface casing.

Gas samples from the production casing and the bradenhead were collected on May 15, 2018 and submitted to Isotech for analysis. Preliminary results are expected on June 1, 2018.

During removal of the wellhead excavated soil will be monitored for any indication of staining. Eight soil grab samples will be collected from the base and/or side walls of the excavated area for analysis of GRO, DRO, and BTEX.
