Comment:

Offsite Tank battery: Germination was observed at the location but large patches of bare ground with weedy, annual vegetation was observed. At a minimum, the Operator needs to control the weedy, annual vegetation (Kochia). Operator may need to perform additional reclamation activities, as large bare patches were observed.

Well location to the north meets Rule 1004 standards.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct followup inspections prior to receiving said notice to ensure compliance with Rule 1004.

Corrective Action:

Operator shall implement Best Management Practices to control and manage Kochia weeds to prevent weed waste and to prevent the spread of dispersing seeds onto adjacent lands.
