This work was scheduled to be completed June 2018, but is not yet finished. This well is monitored on a continual basis and has 1,500 psi +/- on the csg and tbg. The well will be placed back on production as soon as we receive confirmation from XTO that we are able to. All production reports that were missing for the 2017-2018 years have been submitted to the COGCC via the e-form system.
