The only improvements that lie within the 500'-1000' buffer area of the wellsite are the East ROW of CR 31 is approx 64' West, an overhead power line falls approx 581' North of the wellsite and the South ROW of CR 3R falls approx 417' North, Windfarm road falls approx. 363' South and a Wind tower falls approx 342' Southeast of wellpad and 550' Southeast of well head.
