The Colorado Oil and Gas Conservation Commission (COGCC) received your complaint regarding air quality relating to the Stahle Pinnacle Unit 10-30. Your complaint is recorded in document number 200446158 and can be reviewed via the "Complaints" link, on our website (<http://cogcc.state.co.us/>).

The actions taken to address your complaint are summarized below.

- COGCC Field Inspection Unit Staff reviewed your complaint;

2017 COGCC annual production peaked at 958 bbl. At the CDPHE (Reg 7, XVII.C.2.a.(i)) default emission rate of 13.7 lb/bbl, the 2017 VOC emission rate was 6.56 tons, which exceeds the threshold for installation of VOC emission control (Reg 7, XVII.C.1.b). Thus, the condensate tank should have an emission control installed before continuing operation. FLIR video provided at: https://youtu.be/9Z-o_CDsNXw
