



WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the TATANKA FEDERAL LD13-625 to be 335' from the EAST line and 1919' from the SOUTH line as measured at right angles from the section line of Section 15, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 140' from the EAST line and 940' from the SOUTH line as measured at right angles from the section line of Section 13, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

The lineal dimensions as shown herein are grid distances based upon the "U.S. Survey Foot." To get ground distances multiply shown distance by 1.000238434.


