	<p>Previous inspections documented various equipment and risers remaining on location and required their removal and additional reclamation activities to be conducted. At time of inspection location was in non-cropland. Area of the location has been converted into cropland.</p> <p>This location does not meet reclamation requirements. Pipe riser remains on Citations location and appears to be interfering with farming activities. Areas around the location remain bare and exposed soil where crop vegetation has been unable to establish, or predominantly undesirable weedy plant species. Additional reclamation activities are required. See "COGCC Comments" for additional comments regarding riser..</p>	
Corrective Action:	<p>Remove riser and perform additional reclamation activities in accordance to COGCC 1000 series rules and requirements. To allow Citation time to 1) determine issues on location hindering crop establishment/reclamation, 2) collaborate with the surface owner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production, and 3) collaborate with the midstream company to remove the riser remaining on the location, all reclamation activities shall be completed no later than 10/31/2018</p>	Date 10/31/2018
