Well is part of the 14-well AE29-05 Multi (Doc #401636272) (Loc ID 435539, fka Wells Ranch AE330-67-1AHNA Multi), consisting of the nine (9) existing Wells Ranch AE30-64HNC (API: 05-123-38642), Wells Ranch AE30-65HNC (API: 05-123-38644), Wells Ranch AE30-65-1BHNB (API: 05-123-38645), Wells Ranch AE30-65-1HNC (API: 05-123-38646), Wells Ranch AE30-67-1AHNC (API: 05-123-38647), Wells Ranch AE30-66-1AHNC (API: 05-123-38649), Wells Ranch AE30-67-1BHNA (API: 05-123-38650), Wells Ranch AE30-65-1AHNB (API: 05-123-38652), Wells Ranch AE30-66-1BHNB (API: 05-123-38653); and the five (5) proposed Wells Ranch AE29-631 (Doc #401636258), Wells Ranch AE29-640 (Doc #401636229), Wells Ranch AE29-650 (Doc #401636220), Wells Ranch AE29-660 (Doc #401636169), and Wells Ranch AE29-669 - Ref. Well (Doc #401636104); with the production facilities within the disturbance. The original Form 2A disturbance was 26.0 acres during construction. A previously unpermitted 2.6 acres will be added, for a new total of 28.6 acres during construction. Location size after interim reclamation will decrease from the originally permitted 14.8 acres to 14.6 acres after amending the location.

Distance to property line is from already existing equipment and wells.
No new equipment is proposed with this amendment beyond wells and pump jacks. The five proposed wells are all >150' from property line.

1	Planning	Lighting on location is considered temporary and will be used during recompletion activities. Permanent lighting will not be installed and utilized during normal production operations. Temporary lighting will be directed downward, inward, and shielded towards location to avoid glare on public roads and Building Units within 1,000 feet. Lighting will be turned off when practical, i.e., no operations being conducted.
2	General Housekeeping	Housekeeping will consist of neat and orderly storage of materials and fluids. Wastes will be temporarily stored in sealed containers and regularly collected and disposed of at offsite, suitable facilities. If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup of trash and discarded materials will be conducted at the end of each work day. Cleanup will consist of patrolling the roadway, access areas, and other work areas to pickup trash, scrap debris, other discarded materials, and any contaminated soil. These materials will be disposed of properly.
3	Storm Water/Erosion Control	Stormwater management plans (SWMP) are in place to address construction, drilling, and operations associated with Oil & Gas development throughout the state of Colorado in accordance with Colorado Department of Public Health and Environment (CDPHE) and General Permit No.'s: COR03N578; COR03N579; COR03N580; and COR03O059. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. Specific BMP's used may include stockpile stabilization, grading, sediment traps, and perimeter barriers based on final construction design and will remain in place until the pad reaches final reclamation.
4	Material Handling and Spill Prevention	Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil & Gas operations throughout the state of Colorado in accordance with CFR 112.
5	Dust control	Noble shall employ practices for control of fugitive dust caused by their operations. Such practices shall include but are not limited to the use of speed restrictions, regular road maintenance, restriction of construction activity during high- wind days, and silica dust controls when handling sand used in hydraulic fracturing operations. Additional management practices such as road surfacing, wind breaks and barriers, or automation of wells to reduce truck traffic may also be used if technologically feasible and economically reasonable to minimize fugitive dust emissions.
