COMMENTS:

SandRidge respectfully requests the right to flare this well due to the following circumstances. 1) The closest/most practical pipeline tie-in point is over 100 miles away. 2) It will take several years to construct a pipeline to said tie-in point, once required ROW and permits are obtained. Additionally, construction will cost over \$50 million, and traverse BLM land. 3) An average of ~300-500 mcf/d will be flared for the first year, and then will decline in subsequent years. The BTU content of the gas is anticipated to be ~1400-1500 and H2S=0 ppm. SandRidge will continue to comply with Rule 805b (1), Rule 912 and monthly reporting of flared volumes (via Form 7). SandRidge will use CPHE approved flaring methods (enclosed flares). SandRidge has an internal air compliance team, as well as a Colorado-based environmental consultant to assist with monitoring air and environmental compliance.
