Mr. Otness,

HighPoint Operating Corporation ("HPOC") is proposing to drill and subsequently treat wells that are located within approximately 150 feet from wells operated by Noble Energy, Inc ("Noble").

Per the Colorado Oil and Gas Conservation Commission's ("COGCC") Rule 317.s, "*No portion of a proposed wellbore's treated interval shall be located within 150 feet of an existing (producing, shut-in, or temporarily abandoned) or permitted oil and gas wellbore's treated interval belonging to another operator without the signed consent of the operator of the encroached upon wellbore*".

HPOC is respectfully requesting Noble Energy, Inc. to waive the requirement and allow HPOC to drill the wells as reflected on Exhibit "A". Accordingly, by executing this letter, Noble waives COGCC Rule 317.s and grants its consent to allow HPOC to drill the wells listed on Exhibit "A" within the 150' minimum intra-well distance provided for in said rule.


