The latest date of first production for the active wells is 4/2015 (123-39260, 5A #400765839). Interim reclamation on areas not reasonably needed for production should have been conducted by 4/2016 in accordance to 1003.b</p> <p>After additional review, operator submitted amended 2A #401277131 on 6/09/2017 and added three additional wells to the location.</p> <p>It is noted that operator states within the 2A that construction activities were planned to commence on 11/15/2017 with interim reclamation planned 5/1/2018.
