A List B Colorado noxious thistle (Canada thistle) was observed throughout the location. Mowing operations would not be considered long term weed management and would likely spread the seeds since the observed thistles have viable seedheads.

Corrective Action

Properly remove and control noxious weeds throughout the location. Ongoing weed management and monitoring is required, and needs to occur in accordance to COGCC rules and regulations.
