Comment Areas no longer needed for Use, Production, Drilling or Subsequent Operations have not been reclaimed. Much of the areas that have been vegetated are sparsely vegetated with desirable species and weedy with Tumble Mustard, Cheat grass and Bindweed. Heavy infestation of Kochia is established on Location & access roads. Only one patch of Knapweed was noted. Kochia growth on Pad is entered in Housekeeping section. Refer to Photos attached for detail of Site conditions.

Corrective Action Reclaim Location for Interim Reclamation per COGCC 1003 Series Rules; installing Reclamation in areas no longer needed for Use, Production, Drilling or Subsequent Operations. Vegetate currently weed dominated and sparsely vegetated areas of Slopes and Berms, incorporating with Interim Reclamation activities which should be complete by 5/31/19.
