## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Soil impacts were discovered around the separator during 1/23/18 tank battery abandonment activities. Consequently, on 1/23/18, seven test pit excavations were dug, using a backhoe, from 7 feet to 9.5 feet below ground surface (bgs). During the test pit excavation investigation, potential petroleum hydrocarbon impacted soil was encountered. A Form 19 Initial w/ Supplemental was submitted on 1/25/18 and approved on 1/29/18, proposing additional site investigation activities. To delineate the investigation area, twelve soil borings were advanced on 3/8/18 to depths ranging from 20 feet to 29 feet bgs. Groundwater was encountered at depths ranging from 21 feet to 25 feet bgs. Consequently, three of the soil borings were converted into monitoring wells. Soil impacts were observed in six of the soil borings around the former location of the separator. Boring locations and soil analytical results are illustrated on Figure 2 and summarized in Table 1. During groundwater sampling activities on 4/9/18 and 7/30/18, free product was encountered in monitoring well MW-1 and benzene concentrations in the groundwater samples from MW-2 were greater than the COGCC Table 910-1 concentration level of 5 micrograms per liter (ug/L). Benzene, toluene, ethylbenzene, and total xylene (BTEX) concentrations were not detected at or above laboratory reporting limits in the groundwater samples from monitoring well MW-3. Monitoring well locations and groundwater analytical results are illustrated on Figure 3 and summarized in Table 2.

Olsson Associates (Olsson) plans to complete an additional Geoprobe investigation once Great Western Operating Company, LLC (GWOC) receives permission from the landowner to the west of the site to drill on their property and install 2 additional monitoring wells. During the investigation, additional boreholes will be advanced in the source area and to the southwest of the source area to further delineate soil and groundwater impacts. See attached Figure 4 for proposed borehole and monitoring well locations.

Groundwater monitoring for BTEX compound concentrations and apparent biodegradation processes will continue on a quarterly basis during 2018 and 2019, with the next quarterly sampling event to occur in October 2018. The two wells to be installed during the additional investigation will be incorporated into the monitoring plan upon installation.
