RE: Rule 325. i. Notification:

EWS 4B Well: 2193' FSL, 483' FEL, Sec. 18-T2N-R63W, Weld County, Colorado

You are being provided this as notice that EWS 4 DJ Basin, LLC is applying to the Colorado Oil and Gas Conservation Commission (COGCC) to drill the above referenced well at the described surface location. Colorado Oil and Gas Conservation Commission Rule 325.i. stipulates that notice of the application for a dedicated injection well shall be given by the applicant by registered or certified mail or by personal delivery, to each surface owner and owner as defined in §34-60-103(7), C.R.S., within one-quarter (1/4) mile of the proposed well or wells and to owners and operators of oil and gas wells producing from the injection zone within one-half (1/2) mile of the disposal well or to owners of cornering and contiguous units where injection will occur into the producing zones, whichever is the greater distance.

b. Location and a general description of the proposed Well & facilities:

One Underground Injection Control (UIC) well. The surface injection facilities will be the already constructed EWS 4 facility.

The injection zones for this well are, in descending order by true vertical depth (TVD), as follows. The depths are approximate and may vary based on geology.

EWS 4B will be a directional well with an approximate bottomhole location of SENW, Sec. 20-T2N-R63W (approximately 40.126519, -104.464115) and a proposed depth of approximately 10,190 feet (TVD) and a measured depth of approximately 11,237 feet.

c. Anticipated date operations will commence:

Operations are planned to commence in the Fourth Quarter of 2018. The exact date will vary based upon rig availability and other operational factors.

You are also entitled to file a request as follows:

Subparagraph i -Any person who would be directly and adversely affected or aggrieved by the authorization of the underground disposal into the proposed injection zone may file, within fifteen (15) days of notification, a written request for a public hearing before the Commission, provided such request meets the protest requirements specified in subparagraph m. of this rule. The notice shall also state that additional information on the operation of the proposed disposal well may be obtained at the Commission office.

Subparagraph m. - Evaluation of written requests for public hearing. Written requests for public hearing before the Commission by a person, notified in accordance with subparagraphs i. and j. of this rule, who may be directly and adversely affected or aggrieved by the authorization of the underground disposal into the proposed injection zone, shall be reviewed and evaluated by the Director in consultation with the applicant.

Written protests shall specifically provide information on:

- a. Possible conflicts between the injection zone's proposed disposal use and present or future use as a source of drinking water or present or future use as a source of hydrocarbons, or
- b. Operations at the well site which may affect potential and current sources of drinking water.
