Followup to Coachman reported spill into lined tank battery containment. Location is now signed as TEP property.
Spill was hydro-vacced and disposed.
Also inspected multi-well pit 430452. F-15 for this pit is expired.
Pit has ~8ft of freeboard. No holes or tears observed in liner. Netting and fencing appeared in good condition with no apparent openings.
New support posts and deadmen have been installed since 2016 support failure during snowstorm.
