Comment:

Previous inspections documented insufficient vegetative cover on location and a deep gulley along the access road. Inspections required operator to conduct additional reclamation activities on the location, and to reclaim and stabilize gulley along access road.

Unable to find evidence that reclamation has been conducted; Large areas of the location remains bare and exposed soil. Gulley along access road remains evident. Original corrective action and date remains applicable.

Corrective Action:

Reclaim gulley along access road and location, establish vegetation with total perennial, noninvasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture that matches the adjacent pastureland or a seed mixture requested by the landowner. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed. Revegetation activities shall be complete no later than 11/15/2016
