INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

Moved in pulling unit and killed well with water. Pulled tubing. Ran correlation log and perforated 7" production casing opposite the Dakota sand from 5520' - 5525' RBM and from 5540' - 5560' RBM with 2 jet shots per foot. Re-Ran tubing, swabbed well in and released pulling unit.

Before perforating well tested 7 bbls. oil, 2,296 MCF of CO₂ gas and 10 bbls. of water per day on 4-13-61.

After perforating well tested 8 bbls. oil, 1,739 MCF of CO₂ gas and 22 bbls. of water per day on 5-25-61.
