 Pumped 8 sx. cement plug with top plug down casing with 45 bbls. Plug from 1877' to 1950'.
 Cut 5-1/2" casing at 895' depth. Pulled casing.
 Ran 2-3/8" tubing to top of stub. Could not get into stub.
 Set 20 sx cement plug thru tubing from 810' to 898' depth.
 Set 30 sx cement plug thru tubing from 275' to 375' depth.
 Set 10 sx. cement plug from 30' to top of 8-5/8" casing.
 Welded plate in top of 8-5/8" casing 3 ft. below ground level.
 Interval between plugs heavy mud.
