- 10-3-52 Spudded
 10-6-52 Ran and cemented 8 5/8" casing at 605' with 300 sacks.
 10-10-52 Core #1 4637-82' Recovered 45' shale and siltstone.
 10-13-52 DST #1 4635-4645' open 1 hour. Good blow in 15 minutes. Decreased to weak in 30 minutes. Recovered 690' water with thin scum of oil. Sand none to trace visible porosity, no oil stain. Very scattered SF, faint to fair ECF. DST #2 4750-80' open 32 minutes. Recovered 1530' water with no show of oil.
 10-14-52 Spotted cement plug from 4790 feet to 4600 feet. Then placed mud taken from the bottom of the mud pit from 4600' to 620' where a cement plug was spotted to 530 feet. Then heavy mud was run to 10 feet where a cement plug was placed to the surface in such a manner as not to interfere with surface cultivation.
