<p><b>Comment:</b> This location was not in compliance with Rule 1002.f. when COGCC Staff arrived on location. Operator failed to install stormwater BMPs prior to, or at, the start of construction. Operator installed a temporary stormwater BMP (ditch) during my inspection. The ditch BMP would not be considered a proper functioning BMP because unconsolidated material has not been properly stabilized. Unconsolidated material becomes a source of potential pollution itself. Operator plans to install silt fence as a permanent BMP.</p> <p>A follow-up inspection will be conducted to ensure compliance with Rule 1002.f. standards.</p>						
<p><b>Corrective Action:</b> Install or repair required BMPs per Rule 1002.f. in accordance with good engineering practices. Corrective action date is being back dated to when stormwater BMPs should have been installed.</p>						<p><b>Date:</b> 09/20/2018</p>
