Comment COGCC Staff discussed and explained the two options moving forward. Operator representatives indicated Great Western (GW) will comply to perform additional reclamation activities per Rule 1003. In addition, GW said they will contact the tenant farmer to coordinate efforts moving forward. Note: The corrective date is not intended to be the date for which the Operator shall comply with Rule 1003 but rather, it is the date the location was observed out of compliance.

Corrective Action Perform reclamation in accordance with Interim Reclamation Rule 1003. Establish vegetation with, non invasive, uniform plant cover of at least eighty (80) percent of reference area levels. Collaborate with the landowner to determine mitigating measures that will allow reclamation work to be conducted in such a manner as to not interfere with agricultural activities or crop production.
