TEP Rocky Mountain LLC (TEP) respectfully requests approval to repair the production casing in the Federal SR 543-9 well per the following proposed procedure:

1. MIRU service unit, kill well.
2. NU BOP and test.
3. POOH 2-3/8" tubing.
4. RIH with 4-1/2" RBP and Packer.
5. Test casing and determine depth of hole in casing.
6. POOH with RBP and packer.
7. Manually backoff production casing below joint with hole.
8. POOH with casing, lay down joint with hole.
9. RIH with casing and screw back into existing casing.
10. RIH with packer and pressure test casing.
11. POOH with packer.
12. RIH with production tubing. Land tubing at 8,735'.
13. RDMO service unit.
